Letter from our president

When our friends and family came together to start the Steven Vanover Foundation (SVF) in 2015, I don't think we ever could have predicted that the organization would make such a huge difference in such a short period of time. Although, knowing Steven, we probably should have assumed that sometimes a short period of time is all you need to make a lasting impact.

2017 was a year of tremendous progress and gratitude. We continued to carry out our mission by funding both memorial scholarships in Steven's honor and rare cancer research. Thanks to your generosity and support, SVF donated over \$130,000 last year, and has raised \$280,000 since the organization's inception. This wouldn't be possible without the steadfast, overwhelming support of our donors, volunteers and community partners.

We hit an important milestone in 2017 when we learned that SVF is the organization making the largest financial contribution to a study taking place at Memorial Sloan Kettering Cancer Center (MSK) that can extend the lives of patients with the type of cancer that took Steven's life - desmoplastic small round cell tumor (DSRCT) - and other rare cancers. Thanks to generous donors like you, we contributed \$100,000 to MSK, which is going toward completing the only phase II trial in United States focused on developing treatments for DSRCT. We are making a direct improvement in the lives of patients like Steven and families like my own. This drives us to continue to grow our organization so we can make even larger strides in the future.

2017 Annual Report

A portion of the money raised over the past year also helped fund three different scholarships: the University of Louisville J.B. Speed School of Engineering scholarship provides financial assistance for a high-achieving young man or woman pursuing an engineering degree; a scholarship at St. Xavier High School helps a deserving young man complete his education at Steven's alma mater; our newest scholarship is awarded to a graduating student from St. Albert the Great School to help fund their tuition at a local Catholic high school. We watched as all three scholarships grew in size to help students at three different academic institutions, all thanks to the continued generosity of our donors.

In closing, this organization hit new heights in 2017 and continues to make a positive difference in the lives of others. We wouldn't be where we are today without you. On behalf of the board of directors, I would like to express my deepest gratitude for your help over the past year and we are excited to see what milestones we can reach together in 2018

Financial summary and commitments

Expenses

As outlined by the Better Business Bureau (BBB) Standards for Charity Accountability, a nonprofit organization should spend no more than 35 percent of related contributions on fundraising. SVF held expenses to approximately 4.61 percent – well under the BBB recommendation.


Reserves

A reserve balance of \$15,956.07 was held at the end of the 2017 for expenses that are planned to be used for upcoming 2018 programming and donations.

Donations

University of Louisville J.B. Speed School of Engineering Scholarship

The Steven D. Vanover Scholarship was established in 2016 to provide financial aid for deserving students as they work to meet their personal, academic and professional goals while achieving their engineering degree. The scholarship is fully endowed and SVF has donated \$38,250 to date to grow the scholarship. The recipient must be involved in campus life, participate in community service, achieve a minimum of a 2.5 GPA and explain why University of Louisville is important to him or her. The second recipient of the Steven D. Vanover Scholarship was Joseph Graf, awarded on Apr. 25.

St. Xavier Brother Benjamin Burke, C.F.X. Endowment

A \$17,500 donation was made on behalf of Steven D. Vanover to the Brother Benjamin Burke, C.F.X. Endowment at St. Xavier High School. The endowment was established to financially aid need-based students. Steven graduated from St. Xavier High School in 2008, and made some of his closest friends during his four years there.

St. Albert Steven Vanover Award & Scholarship

The Steven Vanover Award & Scholarship was established at St. Albert the Great Catholic School, where Steven graduated in 2004. The award and \$500 scholarship is presented to an eighth grade student who achieved academically, exhibited leadership qualities and participated in extra-curricular activities during their years at St. Albert, and can be used toward high school expenses.

Memorial Sloan Kettering Rare Cancer Research

According to Memorial Sloan Kettering Cancer Center, the type of cancer that Steven had, Desmoplastic Small Round Cell Tumor (DSRCT), is "a rare type of soft tissue sarcoma with a poor prognosis" and "an aggressive tumor that typically occurs in the abdomen and pelvis of an adolescent or young adult." The most common symptom is abdominal pain and/or a mass in the abdomen, and the origin of DSRCT in the body may not be known. Each year, 20 individuals are diagnosed with this type of cancer in the United States. Steven was one of these 20.

Shakeel Modak, M.D., a pediatric oncologist at Memorial Sloan Kettering, is leading a

study on a type of therapy to combat DSRCT. In previous years, SVF was able to contribute funding to Phase I of the study and the transition into Phase II. Dr. Modak sent a letter of gratitude for the philanthropic support and provided details of the study.

Dr. Modak said in his letter, "The Phase 1 trial is complete. Incorporated into the Phase I trial was a group of patients treated on the Phase II design. A total of 44 patients were treated including 10 on the Phase II design. The formal Phase II protocol has started going through the committees. In the interim, we have Institutional Review Board (IRB) approval to add 3 extra patients while

the Phase II trial opens (making a total of 13 patients on the Phase II design). The Phase II trial will likely open in three to four months."

Dr. Modak added that a paper on the trial will be submitted and SVF will be acknowledged for its contributions and importance to the research. Dr. Modak's mission, like the SVF mission, is to bring hope to DSRCT patients and their families. Due to the rarity and small amount of research on the type of cancer that Steven suffered from, SVF has gifted \$100,000 in 2017 to aid Dr. Modak's clinical study, bringing our total donation to \$195,000 since 2015.
